

Project History



- Per LWDD Policy, approval to Pipe a canal in order to use for parking is based on an approved hardship
- Due to the history of this project and the configuration of the L-20 Canal through the subject parcel, staff feels that it meets the requirements of a hardship
- May 2002 LWDD Board of Supervisors (Board) approved the piping of a portion of the L-20 Canal under a Piping, Paving, and Parking License Agreement between LWDD and Mr. Pribell
- April 2006 Mr. Pribell returned and the Board approved the Piping, Paving, and Parking License Agreement
- September 2007 Mr. Pribell returned and the Board approved the sale of a portion of the L-20 Canal Right-of-Way to Mr. Pribell; Mr. Pribell conveyed an exclusive 80' easement to LWDD; The Piping, Paving, and Parking License Agreement was approved

Project History continued




- March 2008 Mr. Pribell paid \$130,500 FMV (26,100 sq. ft x \$5.00) for a portion of L-20 Canal; QCD and Easement Deed were recorded
- November 2008 Board approved Piping, Paving, and Parking License Agreement on the Consent Agenda
- September 2009 Board approved Piping, Paving, and Parking License Agreement
- November 2009 Board denied issuing a Piping,
 Paving, and Parking License Agreement/Permit without fees being paid




- Issue a Right-of-Way Permit for the Piping and Paving for a portion of the L-20 Canal

 - \$9.00 PLF x 305 Feet = \$2,745.00
 - · One Time Use Fee:
 - \$20.00 PLF x 305 Feet = \$6,100.00
 - Annual Fee:
 - \$4.00 PLF x 305 Feet = \$1,220.00 (Adjusted every 5 years by the compounded CPI)









Background



- At its April 13, 2016 meeting, Board gave conceptual approval to the proposed design by Florida's Turnpike Enterprise for widening of Florida's Turnpike to eight lanes from Boynton Beach Blvd. to Lake Worth Road
 - Part of proposed design included constructing a bulkhead wall within the eastern most 20 feet of the LWDD E-2W Canal to provide sufficient room for the road widening
 - Proposed bulkhead wall will not only address proposed widening requirements, but will also alleviate the existing erosion and maintenance concerns of LWDD
- Conceptual approval was subject to five (5) considerations

Conceptual Approval Considerations



- 1. Fees, both property value and permit, TBD; mitigation of fees could occur as result of the Florida's Turnpike Enterprise work required on the E-2W Canal
 - District staff and Florida's Turnpike Enterprise staff have worked to determine the fees and other mitigating requirements relative to the proposed widening and design plans have been reviewed and approved
 - The required associated fees were calculated and Florida's Turnpike Enterprise has submitted these fees to the District

Conceptual Approval Considerations



- 2. Hydraulic modeling showing any potential impacts to the canal as a result of the channel being slightly restricted
 - Drainage calculations have been provided by Florida's Turnpike Enterprise that shows that the capacity and flow rates for the design section of the LWDD E-2W Canal will not be adversely affected by the proposed bulkhead wall encroaching into the existing canal rightof-way

Conceptual Approval Considerations




- 3. Florida's Turnpike Enterprise to install permanent culvert crossings (to LWDD standards) for the benefit of the Turnpike Contractor and LWDD
 - Included in the design plans is a 72" reinforced concrete box culvert to replace the existing Turnpike bridge over the LWDD L-14 Canal
 - On the west side of this new culvert Florida's Turnpike Enterprise is constructing, per LWDD specifications, an operable emergency control structure to separate the 16-foot control basin from the 13-foot control basin


- 4. Florida's Turnpike Enterprise agrees to construct the E-2W canal to its full design section from the West to the East R/W for the limits of the project
 - After further review of existing condition of E-2W
 Canal it has been determined that no work by
 Florida's Turnpike Enterprise will be required except the work required to construct the bulkhead wall as detailed on the approved design plans



Conceptual Approval Considerations



- 5. Rip-rap rubble to be installed on both sides of the E-2W for the length of the project limits to LWDD satisfaction
 - Drainage calculations have been provided by Florida's Turnpike Enterprise that shows that the capacity and flow rates for the design section of the LWDD E-2W Canal will not be adversely affected by the proposed bulkhead wall encroaching into the existing canal right-of-way. However, to reduce future maintenance and operation efforts that will be affected with the addition of the proposed bulkhead wall LWDD will require that rip-rap rubble be installed for the length of the project along the west side of the channel of the E-2W canal pursuant to the typical section that was presented for the conceptual approval at the April 13, 2016 Board meeting



Project Status



- Upon completion of construction and final inspection, LWDD will transfer to Florida's Turnpike Enterprise fee simple ownership of the right-of-way between the current west right-of-way line of Florida's Turnpike (east right-of-way line of E-2W Canal) and the westerly side of the newly constructed bulkhead wall
- Florida's Turnpike Enterprise submitted permit application and associated fees
- District staff is reviewing the design plans for future permit issuance
- LWDD and Florida's Turnpike Enterprise propose entering into a Memorandum of Agreement to further define ownership and maintenance obligations during and post construction

Memorandum of Agreement



Project specific obligations for Florida's Turnpike Enterprise:

- Procure a Construction Engineering and Inspection firm, manage the construction of the project, and provide inspection oversight for the bulkhead wall construction at no expense to LWDD
- Provide LWDD with access based on project's approved and permitted design plans from Turnpike SR 91 for LWDD to operate the L-14 Canal control structure on the proposed culvert; and provide notice to LWDD of any L-14 control structure maintenance issues noticed by Florida's Turnpike Enterprise during normal roadway operations by Florida's Turnpike Enterprise, including traffic accidents that may occur at the control structure maintenance area

Memorandum of Agreement



Project specific obligations for LWDD:

- Issue all required Right-of-Way permits upon review and approval of the project's design plans
- Continue to operate and maintain the various canals within the project boundaries during construction while Florida's Turnpike Enterprise's contractor works within the canals pursuant to the approved permitted plans
- Transfer to Florida's Turnpike Enterprise, in fee simple ownership via quit claim deed, the right-of-way containing the bulkhead wall after construction and final inspection/acceptance of the project by LWDD
- After construction and final inspection/acceptance of the project and upon coordination with LWDD, LWDD will provide Florida's Turnpike Enterprise with access to E-2W Canal for inspection and maintenance of bulkhead wall. LWDD will provide vegetation maintenance, as needed, for the bulkhead wall
- Provide notice to Florida's Turnpike Enterprise of any bulkhead wall maintenance issues noticed by LWDD during LWDD's normal canal operations, including incidental contact with the bulkhead wall during canal maintenance activities

Memorandum of Agreement



Overall post-construction maintenance responsibilities for Florida's Turnpike Enterprise:

- Structural maintenance of the L-14 Canal culvert and E-2W Canal bulkhead wall
- Maintenance of bridges and culverts within LWDD right-of-way within the limits of this project
- Maintenance of improvements within the LWDD transferred right-of-way including the bulkhead wall and associated appurtenances

Overall post-construction maintenance responsibilities for LWDD:


- Structural maintenance of the L-14 Canal culvert control structure
- Maintenance of the canal and water flow

Background



- Canal Rehabilitation Program requires the support of surveying services

Annual Surveying Services for Canal Rehabilitation Program RFP




Proposed Timeline

- November 14 Board approval to enter into contracts with selected firms



 - Basic Mechanical / Electrical Layout & Design






