Chapter 4: Restrictions & Requirements within Right-of-Way

4.8 Use of Right-of-Way as Temporary Access

Requests for Use of LWDD's Right-of-Way as Temporary Access

All requests will be considered by the LWDD Board of Supervisors (Board) on an individual basis. If approved by the Board, the following guidelines apply:

4.8.1

The petitioner shall enter into a license agreement to indemnify and hold harmless LWDD from any damages resulting from the use of the right-of-way.

4.8.2

Proof of minimum of \$1,000,000.00 liability must be furnished to LWDD.

4.8.3

The petitioner shall pay any legal fees incurred by LWDD in drafting and review of the necessary documents.

4.8.4

The petitioner shall furnish a bond or letter of credit equal to \$50.00 per linear foot of right-of-way to be used, plus \$500.00 for equipment mobilization, to guarantee the return of the right-of-way to its original condition.

4.8.5

The License Agreement may be terminated orally or in writing immediately at the sole discretion of the LWDD Manager, Assistant Manager or Board of Supervisors.

4.8.6

Based upon time constraints, the manager is authorized to allow temporary access within LWDD rights-of-way; however, the manager shall report to the Board at the next regularly scheduled Board meeting.
