1. Call to Order

President Bedner called the meeting to order at 8:30 A.M.

2. Pledge of Allegiance

Mr. Alderman led the Pledge of Allegiance.

3. Special Retirement Recognition – Terry E. Lewis, Esq.



8. Election of Board Officers: President, Senior Vice President and Vice President

A nomination for Stephen Bedner for President was made by Supervisor Whitworth, seconded by Supervisor Phipps and approved unanimously.

A nomination for James M. Alderman for Senior Vice President was made by Supervisor Whitworth, seconded by Supervisor Hill and approved unanimously.

A nomination for Carrie Parker Hill for Vice President was made by Supervisor Whitworth, seconded by Supervisor Phipps and approved unanimously.

9. Appointment of District Officers: Tommy B. Strowd, Secretary & District Engineer; Reagan Walker, Assistant Secretary; Karen Hoyt, Treasurer

A motion was made by Vice President Hill to approve the appointment of the District Officers as presented, seconded by Senior Vice President Alderman and approved unanimously.

10. Approval of minutes, check register and financial statement for the previous month

A motion was made by Supervisor Whitworth to approve the minutes, check register and financial statement for the previous month, seconded by Vice President Hill and approved unanimously.

11. Approval to surplus and dispose of designated items – Karen Hoyt, Director of Finance & Administration

Ms. Hoyt stated pursuant to Chapter 274, Florida Statutes, the District has the discretion to surplus property that is obsolete or the continued use of which is uneconomical, unsafe, inefficient, or which serves no useful function. Staff have identified items that meet this criteria and requests that they be declared surplus and disposed of through the recommended disposal method. The list included 15 items consisting of AV equipment, equipment parts and office fixtures. A copy of the list was presented and is attached hereto as part of the meeting record.

Staff recommended approval to declare the listed items as surplus and authorize disposal of items.

A motion was made by Supervisor Whitworth to approve staff recommendation, seconded by Vice President Hill and approved unanimously.

12. Approval to solicit Requests for Proposals for Health Insurance and Liability Insurance Brokerage Services – Karen Hoyt, Director of Finance & Administration

Ms. Hoyt stated during this insurance cycle staff recommends solicitation of a formal Request for Proposal to ensure open and fair competition. She stated the current brokers, Brown & Brown (health insurance) and Preferred Risk Insurance Agency (property, casualty) will be notified and encouraged to submit a proposal. Ms. Hoyt stated services staff is seeking include but are not limited to: soliciting and negotiating annual renewals of insurance coverage; ensuring the District is in compliance with healthcare reform and pertinent legislative requirements; providing informational materials to employees related to enrollment activities, explanation of benefits and wellness programs; routinely evaluating risks and make recommendations for the appropriate mitigation of those risks in a cost-beneficial way; providing information on workers' compensation issues, trends and proposed or new legislation; coordinating notice of claims and/or losses to underwriters and act as a facilitator during claim process.

Ms. Hoyt presented tentative schedules for Health Insurance and Property Casualty proposal solicitations. She stated that the evaluation/selection committee will include herself, Melissa Skora, Reagan Walker and an appointed Board member.

Staff recommended approval to issue Request for Proposals (RFPs) for Brokerage Services for Health Insurance and Employee Benefits in January, followed by Property/Casualty Insurance in February. Appointment of a Board Supervisor to serve on the Evaluation/Selection Committee.

Vice President Hill volunteered to serve on the selection committees.

A motion was made by Supervisor Whitworth to approve staff recommendation and nomination of Vice President Hill to serve on the evaluation/selection committees, seconded by Supervisor Phipps and approved unanimously.

13. Executive Director's Report

Mr. Strowd stated in early January the South Florida Water Management District (SFWMD) issued a notice of rulemaking for their land management policies that includes requirements for landowners, municipalities, counties, and special taxing districts to develop a vegetation debris management plan and submit this plan to the water management district. He stated the rule requires implementing Best Management Practices to manage floating aquatic vegetation to prevent the discharge of trash and vegetation that migrates downstream into SFWMD canals. He stated that implementation of the rule will not affect any best management practices that LWDD already performs. Mr. Strowd stated he attended the public meeting and provided comment on the proposed rule, and that he will submit

written comment by the deadline on January 17, 2023. He will keep the Board updated on any developments.

Supervisor Phipps inquired about the status of roadway widening projects. Mr. Strowd stated discussions were still ongoing with FDOT and the Turnpike Authority on the Atlantic Avenue and Turnpike widening projects, respectively.

Director of Operations & Maintenance Tony LasCasas provided an update on the refurbishment of Control Structure 9. He stated the demolition of the existing buildings started and the project is currently on schedule.

Sr. Vice President Alderman inquired about status of ASR project. Mr. Strowd indicated that staff expects to present the results of the ASR Feasibility Study to the board within the next couple of months.
